### "Breathe Easy: Educating, Empowering & Uniting Communities Against Menthol," public symposium

**Ollie Ganz and Kevin Schroth**, together with Diane Hill, Assistant Chancellor, University-Community Partnerships at Rutgers University-Newark and founder of the Center for Health Excellence and Community Empowerment (CHECE), attended and presented at a public symposium on October 17 held in Union, New Jersey, highlighting the results of a two-year, community-engaged research collaboration aimed at reducing the harmful impact of menthol and flavored tobacco products. The Intergenerational Fight Against Menthol (I-FAM) initiative is led by INTS and CHECE, in collaboration with five community-based organizations in the Greater Newark area.

### RWJMS Wellness Fair

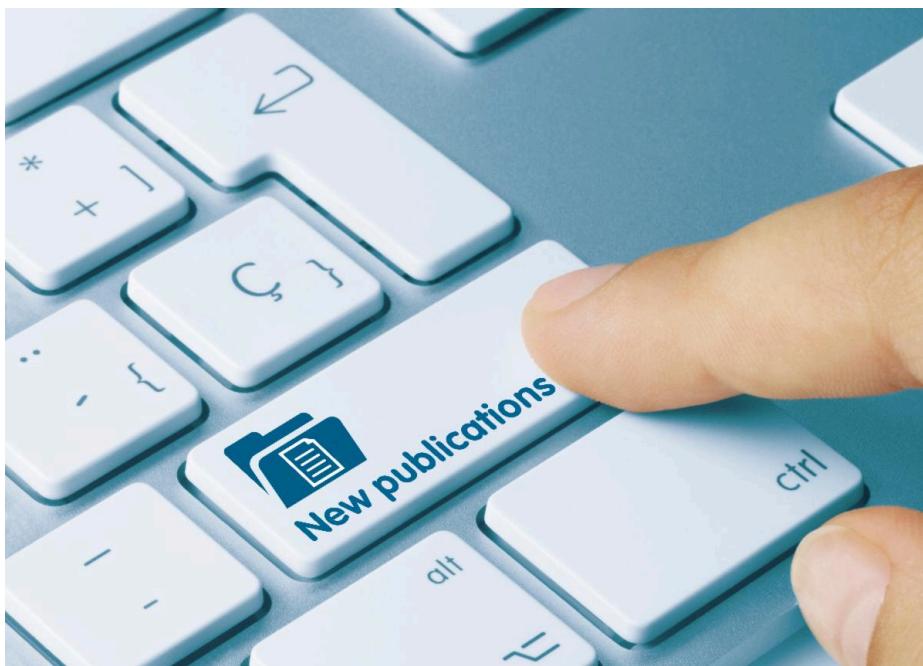
